

Penpol School Nursery Consultation

Thank you for taking the time to read and respond to this statutory proposal for **Penpol School**, **Cornwall**, to make a prescribed alteration.

Overview

We hope to create a **forest school nursery** here on our site at Penpol School.

We are very proud of our onsite forest school provision here at Penpol. We have the opportunity to create a nursery provision on our school grounds, catering for up to 25 three and four-year-olds each session. We would plan to host children funded for 15 hours and those funded for 30 hours. The nursery will be housed in an existing classroom with access to our forest school and to a dedicated outdoor area.

Initial surveys of our current parents/carers and of staff have demonstrated unanimous support of the proposals so far. They also demonstrated a significant level of need for spaces amongst our current families and we are now very keen to hear from the broader community.

Objectives

- We aim to provide parents with an additional level of choice in the town by establishing a teacher-led provision which benefits from extensive and rich outdoor experiences.
- Penpol is a school steeped in oracy at every level and we aim to provide our nursery children with the strongest starts in terms of vocabulary and, therefore, readiness for onward learning.
- The setting would be led by experienced and qualified early-years practitioners, also drawing from the range of expertise and resourcing available from across a large school team.
- In supporting children to feel comfortable and happy in the school environment, we expect to provide them with the strongest start to school in Reception.

Impact Upon Other Providers

As a community school, the admissions criteria for our Reception intake adheres to the Local Authority Admissions Policy (found below). Therefore, parents choosing our nursery would do so on the merits of the nursery offer itself rather than in order to gain a place for Reception. We have informally consulted with other providers and are keen to hear further thoughts on these proposals. Our assessment, and that of the Local Authority, is that there is a need for nursery spaces in the area, particularly as providers seek to accommodate the increased demand of 2-year-olds following recent government announcements.

Our intake will be relatively small, allowing children to enjoy a spacious indoor provision alongside their outdoor environment. Given this, we anticipate running at or close to capacity throughout the year, with per-pupil nursery funding meeting these costs. With our broader school staff team, we are afforded a level of additional flexibility to meet any changes in numbers.
