



# PSHE and RSHE Policy

Personal, Social, Health Education and Relationships Sex and Health

Date of Policy: 9<sup>th</sup> March 2026

Update- March 2027

## Context

All schools must provide a curriculum that is broadly based, balanced and meets the needs of all pupils. Under section 78 of the Education Act 2002 and the Academies Act 2010, a PSHE curriculum:

- Promotes the spiritual, moral, cultural, mental and physical development of pupils at the school and of society, and
- Prepares pupils at the school for the opportunities, responsibilities and experiences of later life.

This policy meets the requirements that schools publish a Relationships and Sex Education policy and does this within the wider context of Personal, Social and Health Education.

## Safeguarding and RSHE

At Penpol School, Relationships, Sex and Health Education forms a key part of our safeguarding curriculum. Through RSHE, pupils are taught the knowledge and skills necessary to keep themselves safe, recognise risk and seek help when needed.

Teaching supports pupils to:

- understand healthy and unhealthy relationships.
- recognise unsafe situations both online and offline.
- develop confidence to report concerns.
- understand consent and personal boundaries in an age-appropriate way.
- recognise harmful behaviour, including bullying, coercion and online exploitation.

This policy operates in conjunction with the school's Safeguarding and Child Protection Policy and reflects the most recent version of *Keeping Children Safe in Education*.

## PSHE

At Penpol School, we teach Personal, Social, Health Education as a whole-school approach to underpin children's development as people and because we believe that this also supports their learning capacity.

The Jigsaw Programme offers us a comprehensive, carefully thought-through Scheme of Work which brings consistency and progression to our children's learning in this vital curriculum area.

The overview of the programme can be seen on the school website.

This also supports the "Personal Development" and "Behaviour and Attitude" aspects evaluated under the Ofsted Inspection Framework, as well as significantly contributing to the school's Safeguarding and Equality Duties, the Government's British Values agenda and the SMSC (Spiritual, Moral, Social, Cultural) development opportunities provided for our children.

## Statutory Relationships and Health Education

Relationships Education and Health Education are statutory subjects in all primary schools under the Children and Social Work Act 2017. At Penpol School, these subjects are delivered through a carefully sequenced PSHE curriculum that is age-appropriate, evidence-informed and rooted in safeguarding principles. Teaching reflects current Department for Education statutory guidance and subsequent updates.

"Today's children and young people are growing up in an increasingly complex world and living their lives seamlessly on and offline. This presents many positive and exciting opportunities, but also challenges and risks. In this environment, children and

young people need to know how to be safe and healthy, and how to manage their academic, personal and social lives in a positive way."

Here, at Penpol School we value PSHE as one way to support children's development as human beings, to enable them to understand and respect who they are, to empower them with a voice and to equip them for life and learning.

We include the statutory Relationships and Health Education within our whole-school PSHE Programme.

To ensure progression and a spiral curriculum, we use Jigsaw, the mindful approach to PSHE, as our chosen teaching and learning programme and tailor it to children's needs. The mapping document: Jigsaw 3-11 and statutory Relationships and Health Education, [jigsaw-3-11-and-rshe-overview-map.pdf \(windows.net\)](#), shows exactly how Jigsaw and therefore our school, meets the statutory Relationships and Health Education requirements.

Jigsaw PSHE regularly updates its materials in response to Department for Education guidance. The school will adopt revised mapping and supporting documents as they are released following the national RSHE guidance updates due for implementation from September 2026.

## What do we teach when and who teaches it?

### Whole-school approach

Jigsaw covers all areas of PSHE for the primary phase including statutory Relationships and Health Education. The table below gives the learning theme of each of the six Puzzles (units) and these are taught across the school; the learning deepens and broadens every year.

Term	Puzzle (Unit)	Content
<b>Autumn 1:</b>	Being Me in My World	Includes understanding my own identity and how I fit well in the class, school and global community. Jigsaw Charter established.
<b>Autumn 2:</b>	Celebrating Difference	Includes anti-bullying (cyber and homophobic bullying included) and understanding
<b>Spring 1:</b>	Dreams and Goals	Includes goal-setting, aspirations, who do I want to become and what would I like to do for work and to contribute to society

<b>Spring 2:</b>	Healthy Me	Includes drugs and alcohol education, self-esteem and confidence as well as healthy lifestyle choices, sleep, nutrition, rest and exercise
<b>Summer 1:</b>	Relationships	Includes understanding friendship, family and other relationships, conflict resolution and communication skills, bereavement and loss
<b>Summer 2:</b>	Changing Me	Includes Relationships and Sex Education in the context of coping positively with change

At Penpol School we allocate time to PSHE each week, in a flexible manner, in order to teach the PSHE knowledge and skills in a developmental and age-appropriate way. These explicit lessons are reinforced and enhanced in many ways: Assemblies, Learning Charters, through relationships child to child, adult to child and adult to adult across the school and through our very own Penpol values. We aim to 'live' what is learnt and apply it to everyday situations in the school community. Class teachers deliver the lessons to their own classes.

### **Relationships Education**

#### ***What does the DfE statutory guidance on Relationships Education expect children to know by the time they leave primary school?***

Relationships Education in primary schools will cover 'Families and people who care for me', 'Caring friendships', 'Respectful relationships', 'Online relationships', and 'Being safe'. The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the mapping document: Jigsaw 3-11 and Statutory Relationships and Health Education.

It is important to explain that whilst the Relationships Puzzle (unit) in Jigsaw covers most of the statutory Relationships Education, some of the outcomes are also taught elsewhere in Jigsaw e.g. the Celebrating Difference Puzzle helps children appreciate that there are many types of family composition and that each is important to the children involved. This holistic approach ensures the learning is reinforced through the year and across the curriculum.

### **Health Education**

#### ***What does the DfE statutory guidance on Health Education expect children to know by the time they leave primary school?***

Health Education in primary schools will cover 'Mental wellbeing', 'Internet safety and harms', 'Physical health and fitness', 'Healthy eating', 'Drugs, alcohol and tobacco', 'Health and prevention', 'Basic First Aid', 'Changing adolescent body'.

The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the mapping document: Jigsaw 3-11 and Statutory Relationships and Health Education.

Teaching reflects the increasingly digital lives of children. Pupils are supported to understand online relationships, digital footprints, misinformation, age restrictions, image sharing, online pressure and strategies for staying safe when using technology. Learning promotes respectful online behaviour and critical thinking about online content.

It is important to explain that whilst the 'Healthy Me Puzzle' in Jigsaw covers most of the statutory Health Education, some of the outcomes are taught elsewhere in Jigsaw e.g. emotional and mental health is nurtured every lesson through the Calm me time, social skills

are grown every lesson through the Connect us activity and respect is enhanced through the use of the Jigsaw Charter.

Also, teaching children about puberty is now a statutory requirement which sits within the Health Education part of the DfE guidance within the 'Changing adolescent body' strand, and in Jigsaw this is taught as part of the 'Changing Me Puzzle'.

Again, the mapping document transparently shows how the Jigsaw whole-school approach spirals the learning and meets all statutory requirements and more.

### **Sex Education**

The DfE Guidance 2019 (p.23) recommends that all primary schools 'have a sex education programme tailored to the age and the physical and emotional maturity of the pupils.

At Penpol School, Sex Education refers specifically to learning about human reproduction beyond the statutory National Curriculum for Science. This includes how a baby is conceived and born and is taught in an age-appropriate and sensitive manner during upper Key Stage 2. All other elements, including puberty, body changes, relationships and personal safety, form part of statutory Health and Relationships Education.

However, 'Sex Education is not compulsory in primary schools'. (p. 23)

Schools are to determine the content of sex education at primary school. Sex education 'should ensure that both boys and girls are prepared for the changes that adolescence brings and – drawing on knowledge of the human life cycle set out in the national curriculum for science - how a baby is conceived and born'.

At Penpol School, Sex Education refers specifically to learning about human reproduction beyond the statutory National Curriculum for Science. This includes how a baby is conceived and born and is taught in an age-appropriate and sensitive manner during upper Key Stage 2.

All other elements, including puberty, body changes, relationships, personal safety and emotional development, form part of statutory Relationships and Health Education and are taught to all pupils.

We intend to teach this as part of our PSHE lessons, parents have the right to withdraw their child from certain lessons.

The school is committed to working in partnership with parents and carers. Curriculum overviews and information about RSHE content are shared annually, and parents are encouraged to discuss any questions or concerns with the school prior to teaching.

### **Parents' right to request their child be excused from Sex Education**

"Parents have the right to request that their child be withdrawn from some or all of sex education delivered as part of statutory Relationships and Sex Education" DfE Guidance p.17 At Penpol School, puberty is taught as a statutory requirement of Health Education and covered by our Jigsaw PSHE Programme in the 'Changing Me' Puzzle. We conclude that sex education refers to Human Reproduction, and therefore inform parents of their right to request their child be withdrawn from the PSHE lessons that explicitly teach this i.e. the Jigsaw Changing Me Puzzle (unit) e.g.

Year 4, Lesson 2 (Having a baby)

Year 5, Lesson 4 (Conception)

Year 6, Lesson 3 (Conception, birth)

The school will inform parents of this right by letter, that will be sent directly via email before the 'Changing Me' Puzzle begins in Summer Term.

## Monitoring and Review

The RSHE curriculum is monitored by the PSHE Lead and Senior Leadership Team through:

- curriculum review and evaluation;
- lesson observations and learning walks where appropriate;
- pupil voice activities;
- staff feedback;
- governor oversight.

Governors review this policy annually to ensure compliance with statutory guidance and safeguarding expectations. Staff receive appropriate professional development to ensure RSSE is delivered confidently, accurately and sensitively.

## Equality

### **This policy will inform the school's Equalities Plan.**

The DfE Guidance 2019 (p. 15) states, "Schools should ensure that the needs of all pupils are appropriately met, and that all pupils understand the importance of equality and respect. Schools must ensure they comply with the relevant provisions of the Equality Act 2010 under which sexual orientation and gender reassignment are amongst the protected characteristics..."

At the point at which schools consider it appropriate to teach their pupils about LGBT (Lesbian, Gay, Bisexual, Transgender), they should ensure this content is fully integrated into their programmes of study for this area of the curriculum rather than delivered as a stand-alone unit or lesson. Schools are free to determine how they do this, and we expect all pupils to have been taught LGBT content at a timely point as part of this area of the curriculum".

At Penpol School we promote respect for all and value every individual child. We also respect the right of our children, their families and our staff, to hold beliefs, religious or otherwise, and understand that sometimes these may be in tension with our approach to some aspects of Relationships, Health and Sex Education.

Teaching is delivered in a factual, age-appropriate and non-political manner. Staff present information sensitively and objectively while promoting respect for all individuals in accordance with the Equality Act 2010. The school recognises that families may hold differing beliefs and aims to teach RSHE in a way that is respectful whilst ensuring all statutory requirements are met.

## Policy Review

### Relationships Education in Primary schools (Appendix) – DfE Guidance 2019

The focus in primary school should be on teaching the fundamental building blocks and characteristics of positive relationships, with particular reference to friendships, family relationships, and relationships with other children and with adults. The references R3/H5 etc can be cross-referenced on the Jigsaw mapping documents and Puzzle Maps to show which lessons throughout Jigsaw contribute to which statutory outcomes. All statutory outcomes are covered in the Jigsaw 3-11 Programme.

The guidance states that, by the end of primary school:

### Physical health and mental well-being education in Primary schools – DfE Guidance

The focus in primary school should be on teaching the characteristics of good physical health and mental wellbeing. Teachers should be clear that mental well-being is a normal part of daily life, in the same way as physical health.

By the end of primary school:
